OBJECTS CLAUSE OF THE COMPANY

1. To carry on in India the business of retail trade in all its forms, including other retail sale not in stores, stalls or markets, whether through direct sales, online platforms, e-commerce, door-to-door sales, home delivery, or any other mode as may be permissible.
2. To carry on the business of wholesale trading, importing, exporting, marketing, distributing, and dealing in agricultural raw materials, whether processed or unprocessed, including but not limited to cereals, grains, pulses, oilseeds, spices, fruits, vegetables, and other agricultural produce and commodities not elsewhere classified.
3. To engage in the retail sale via stalls, kiosks, temporary

establishments, markets, fairs, exhibitions, and other public or private outlets of food products, beverages, tobacco, and related consumable items, whether manufactured, semi-processed, or raw.

4. To establish, maintain, own, operate, manage or collaborate in retail outlets, wholesale depots, stalls, markets, distribution points, warehouses, godowns, cold storage, showrooms, or any other infrastructure incidental and conducive to the business of the Company.

5. To carry on the business as traders, merchants, importers, exporters, distributors, brokers, stockists, packers, re-packers, processors, preservers, and dealers in all kinds of consumer goods, agricultural produce, food and beverages, health products and allied products.

6. To do all such other lawful things as are incidental or conducive to the attainment of the above objects.

4 The liability of the member(s) is limited, and this liability is limited to the amount unpaid if any, on the shares held by them.

5 Every member of the company undertakes to contribute:

(i) to the assets of the company in the event of its being wound up while he is a member, or within one year after he ceases to be a member, for payment of the debts and liabilities of the company or of such debts and liabilities as may have been contracted before he ceases to be a member; and

(ii) to the costs, charges and expenses of winding up (and for the adjustment of the rights of the contributories among

themselves), such amount as may be required, not exceeding * rupees.
